SMART BETA 2.0 INDEX DESCRIPTION

The U.S. Global Sea to Sky Index uses a smart beta 2.0 strategy to help determine the most efficient marine shipping, air freight and courier, and port and harbor companies in the world using a quantamental stock picking approach. The index uses a combination of fundamental factors to screen for these companies that are listed on well-developed stock exchanges, seeking to provide diversification through exposure to these names. One cannot invest in an index.
